Competent Authority has decided to hold a "Walk-in-Interview" for engagement of Full Time Specialist and General Duty Doctors on contract basis.

1. "Walk-in-Interview" will be conducted by East Central Railway for engagement of full time Specialists and General Duty Medical Practitioner for Division Railway Hospital/ Sonpur and Sub Division Railway Hospital/Garhara of East Central Railway/Sonpur Division. Willing Doctors who fulfill the qualification/ eligibility criteria specified below may apply for the above engagement. The engagement will be purely on Contract basis for the period of one year which can be renewed as a fresh contract on year to year basis (not extendable beyond 20 years or till attaining the age of 65 years whichever is earlier) or till the post filled by regular Doctors selected from UPSC or the scheme is available whichever is earlier.

(h) Original Pension Payment Order book & self attested copy of the same in case of Retd. Doctor.

9. General Conditions and other facilities:

- (a) In the event of absence from duty, deduction from the remuneration will be applicable @ daily rate of proportionate of remuneration.
- (b) Railway administration has legitimate right to transfer the engaged CMP(s) any where over E.C.Railway in case of administrative exigency.
- (c) One set of 1st class complementary pass for self and family shall be issued during each contract period after completion of three months of regular contract service. Contract Medical Practitioner can avail free medical treatment on E.C.Railway Hospital for self only.
- (d) No TA/DA will be paid to the candidates for attending the interview.
- (e) Selected candidates will be posted in any Hospital/Health unit's of Sonpur Divisions of East Central Railway. The vacancies announced are only indicative and Railway reserve the right to make adjustments.
- (f) CMP will have no right of posting against regular vacant post or transfer at his own request.
- (g) CMP will not be allowed private practice after sanction of contract.
- (h) The candidates working in any Medical Organization/State Govt. should submit their applications through proper channel with "No Objection certificate".
- (i) Change of numbers of posts and place as specified above are subject to the condition. Offer of posting will be made on the basis of vacancies available at the time of engagement.
- (j) Posts indicated herein may be kept unfilled at the discretion of Railway administration.

- (k) Contract Medical Practitioners engaged on contract basis in the Railway will not have any claim or right for his/her continuity in service or automatic extension of the term of contract service rendered as a fulltime contract. The service rendered as CMP will not confer the right to take waitage for regular selection through UPSC and also will not confer any right for regularization or absorption.
- (I) If Railway accommodation is provided to the CMPs subject to availability and after meeting the requirement of serving Railway officers, an amount equivalent to HRA payable to afresh entrant to Group 'A' Junior Scale/ Sr.Scale and license fee of the Railway accommodation will be deducted from the monthly remuneration payable to the Contract Medical Practitioner.
- (m) Offer of engagement will be issued in favour of selected candidates; the candidates should report within 15 days from the date of issue of offer letter. The candidates not reported within stipulated time, offer may be treated as cancelled.
- (n) Contract of the CMPs can be terminated by the Railway at any time during the contract period by giving 15 days notice without assigning any reason as per the terms and condition laid down in Railway Board's letter no.96/E(GR)II/9/16 dtd.23.02.2000, Letter No.2016/E(GR)II/1/1 dtd.28.02.2017 & 16.02.2017.
