- Age Limit.** The crucial date for determining the age limit shall be the last date of receipt of application.
 - For Unreserved & EWS candidates - 18 to 25 years** (Relaxable for Government Servant upto 35 years as per orders/instructions issued by the Central Government).
- SC/ST/OBC candidates who apply against unreserved post will not be given any concession of reserved category, as they will be considered in the Un-reserved category.
- The benefits of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by one of the following authorities shall be accepted as proof of candidates claim as belonging to EWS:-
