Candidate should report in the ESIC Hospital, Bhilai, at the Fourth floor of ESIC Hospital, Smriti Nagar, Bhilai, Durg, from 09:00 AM to 11:00 AM on 28-07-2026, Tuesday OR 29-07-26 Wednesday (For Dental Endodontist Specialist and Dental SR against GDMO) candidates reporting after 11:00 AM will not be allowed to appear for the Walk-in-Interview.

Reservation for other reserved categories will be executed as per the existing Central Government Rules.

- 1) Candidates seeking Reservation / Age relaxation benefits under SC/ST/OBC Category must ensure that they are entitled to such reservation as per the eligibility prescribed in the notice and as per the instructions issued by the Government of India. They should also have the certificates in the prescribed format of the Government of India in support of their claim. Candidates seeking reservation under the EWS category should submit their EWS certificate as per the prescribed vide Government of India, Department of Personnel and Training OM no. 36039/1/2019-Estt. (Res.) dated 31/01/2019. Candidates claiming reservation/age relaxation under the OBC category should submit their OBC certificate as prescribed vide Government of India, Department of Personnel and Training, OM no. 36012/22/93-Estt (SCT) dated 08/09/1993, which is modified vide OM No. 36033/3/2004-Estt. (Res.) dated 09/03/2004. Further modified vide OM No. 36033/3/2004-Estt. (Res.) dated 14/10/2008 or the latest notification of the Government of India.
- 2) Interested candidates may appear for the walk-in interview as per the given schedule along with their original documents and Xerox copies in support of their date of birth, proof of education qualification, experienced certificate, caste certificates as per Government of India format, non-creamy layer certificate as per Government of India format in case of OBC. They are advised to appear for an interview with a duly filled Annexure 'A', which is available on the website.
- 3) Private practice of any kind will not be allowed (except for a part-time specialist).
- 4) The number of vacancies/category-wise vacancies may vary/likely to increase or decrease.
- 5) No TA/DA will be paid to candidates for appearing in the walk-in interview.
- 6) Application should be submitted for each post separately.
- 7) The Medical Superintendent reserves the right to fill up all or not to fill up any vacancy.

The Medical Superintendent reserves the right to alter the date or cancel the interview.

- 8) Candidates working in the Government. / Private Hospital / Institute should produce NOC from their department at the time of the interview.
- 9) Senior Residents Scheme 03 Years, as per Central Government Rules adopted by ESIC. No encashment of accumulated leave. The Engagement of the 03-year senior resident will be purely contractual for a one-year tenure, extendable up to a maximum 03 years, subject to the requirement, satisfactory work performance report by HOD & performance of the senior resident.
- 10) Applicants having completed 3 years of Senior Residency period in any hospital are not eligible to apply under the residency scheme. The experience will not be issued in case the SR-3 years and contractual Specialist resigns before completing 6 months of services.
- 11) Remuneration and leave rules are in accordance with the ESIC Hqrs letter No. Z-17/11/1/2007/M-IV dated 13/04/2022.
- 12) A full-time specialist on a contractual basis shall be recruited for a period of 01 year with annual evaluation and term renewed every year based on satisfactory performance.
- 13) He / She must sign the contract on a Non-Judicial Stamp Paper of Rs. 500/-before joining. The original contract will be with the hospital, and its copy will be with the candidates. The cost of the Non-Judicial Stamp Paper will be borne by the candidates.
 - a. The specialist shall be responsible for all cases undergoing treatment under his supervision in his discipline.
 - b. Full-time contractual Specialist and will be entitled to leave @04 days for each month of work on a prorata basis in a calendar year.
 - c. Period of contract for part-time/full-time contractual specialist will be of one year from the date of joining or till regular incumbent joins.
 - d. Senior Residents will be entitled to the leave as per the central residency scheme
- e. Part-time contractual specialist will not be entitled to any kind of leave.
- The selected specialist/super specialist/Senior Resident must have a professional indemnity policy which should cover the period as desired by ESIC in the bid. The policy is meant to cover professional liability falling on them because of errors and omissions committed by them while rendering professional services. The minimum sum assured per annum should be Rs. 30 lakhs for Anesthesiologists, Cardiac Surgeons, Neurosurgeons, Plastic Surgeons, etc. (02) Rs. 20 lakhs for General Surgeons, Gynaecologists, Obstetricians, etc. (03) for physicians, Dentists, Radiologists, Pathologists, etc. should be at least 10 lakhs.
